#### **Basic and Advanced Erosion & Sediment Control Practices (ESC)**

(8 Hours, Classroom) This course is necessary to become a Contractor Certified in Erosion and Sedimentation Control Practices by the Department. In 8-hour course, participants will learn why erosion control practices are important. The course is of primary interest to contractors, municipal code enforcement officers, consultants, engineers, and public works employees.

#### **Erosion & Sediment Control Practices Refresher (ESCR)**

(4 Hours, Classroom) This course is intended as a refresher for basic erosion and sedimentation control (ESC) techniques for DEP-certified individuals seeking re-certification credits.

**Pond Workshop** includes pond planning, design, and construction, and keeping an existing pond. Get clear answers to your questions.... I have algae, what can I do? How can I keep my Pond healthy? What's the best type of Pond for my area (embankment or excavated)? What other uses are there for Ponds? What should I know before I build my Pond?

#### BASIC SEPTIC SYSTEM INSTALLERS WORKSHOP (Septic)

The septic system installation workshop is designed for Contractors, Local Plumbing Inspectors and Site Evaluators. Revisions to the SSWWD Rules, erosion/sediment control, what causes failures and how to avoid them, inspections which can hold up things, the interchangeability of disposal field devices, installer liability, reading and understanding the HHE-200 Form, how water moves into and through the soil, septic system hydrology issues, fill extension retaining walls, back fill specifications and history, installing septic system force mains through wetlands, force main stream crossings, septic system related well contamination case studies, Natural Resources Protection Act and Mandatory Shoreland Zoning issues you should know.

### **Gravel Road Maintenance Workshop (Gravel)**

(4 Hours, Classroom & Field) In this training, participants will learn how proper maintenance protects water quality, gravel road materials, how to evaluate a gravel road for maintenance needs, creating a road maintenance plan, gravel road Best Management Practices. This training is intended to be supply a resource for gravel road owners, town officials, contractors, and watershed organizations to better understand methods and practices for evaluating and maintaining gravel roads.
